II. Old Business

1. Approval of CCTC Meeting Minutes April 7, 2014

CCTC Member Lucas made a Motion to approve the CCTC Meeting Minutes of April 7, 2014, 2nd by CCTC Vice Chairman Branham, CCTC vote was unanimous.

III. New Business

1. Reimbursement from C-Funds to Road Dept. for Winter Patching Material in amount of \$10,530.00

CCTC Member Oliphant made a Motion to approve reimbursement of \$10,530.00 to Road Dept. for Winter Patching Material from C-Funds, 2nd by CCTC Member Holcombe, CCTC vote was unanimous.

2. Reimbursement from C-Funds to Recycle & Litter Control for Sign Material in amount of \$1,259.77

CCTC Vice Chairman Branham made a Motion to approve reimbursement of \$1,259.77 to Recycle & Liter Control Dept. for Sign Material from C-Funds, 2nd by CCTC Member Jordan, CCTC vote was unanimous.

3. Award Bid for Construction Services

CCTC Member Oliphant made a Motion to award the bid for Construction services for the County to the Dennis Corporation, 2nd by CCTC Vice Chairman Branham, CCTC vote was unanimous.

4. Award Bid for Engineering Services

CCTC Vice Chairman Branham made a Motion to award the bid for Engineering services for the County to the Dennis Corporation, 2nd by CCTC Member Holcombe, CCTC vote was unanimous.

5. Update on Roads that have been reclaimed that need to be repaired

Mr. L.B.Cannon said he had been riding the roads done with the reclamation process but it would take some time, however, he is working on this project. He stated that 72 roads have been done since 2007 and 7 are asphalt and in good condition and 65 were done with the stabilization process. He said that he has looked at about 50% of the roads and hasn't found one yet that the integrity of the sub-grade is bad, basically all roads are narrow. He is working with Sanders Brothers at Crystal Creek and they are trying a new type of stone, in fact, DOT is using this new type of stone which is more expensive but last longer and the "rideability" on the road is good. CCTC Member Oliphant asked if the roads he had ridden were in need of repairs. Mr. Cannon said he was making a list that some just needed stone. CCTC Member Oliphant then said that eventually when we get caught up they would all need asphalt and what would need to be done before they deteriorated further. Mr. Cannon said probably one shot of "staylite". CCTC Member Oliphant then requested that Mr. Cannon just let them know then he was finished with his findings. Mr. Cannon then stated that he was working on the 2013 C-Fund Project which included Pinckney Road and a couple of roads off of Pinckney.
