I. Call to Order ~ by Chairman Stuart

II. Pledge of Allegiance & Invocation ~ pledge was said in unison and the invocation was led by CCTC Member Lucas.

III. New Business

- 1. Request to widen Murdock Road – Citizen Wanda Brown** ~ Mrs. Wanda Brown and her husband spoke about their concerns about Murdock Road. She first approached the council in June 2015. This road is county certified but not state certified in width in order to have a bus to come on this road. She has been battling this issue for quite some time. This issue is now effecting her job. Being that she has to take her children to school, her job has worked with her but they will no longer working with her on this issue. There is a state portion side and a county portion side of the road. There have been 2 fatal accidents on this road. There was a lengthy discussion among the council members, Mr. and Mrs. Brown and L.B. Cannon of the Dennis Corporation.

CCTC Chairman Stuart will work with L.B. Cannon to get the right a-ways and necessary items needed to update Murdock Road.

2. **Reimbursement for signage that was replaced in the amount of \$955.82** ~ Motion made by Council Member Branham, 2nd by Council Member Holcombe to approve replacing the \$955.82 from C-Fund money. **The council voted unanimously, 5-0 to approve.**
3. **Request from L&C Railroad to install a railroad “tub” for vehicle traffic on Highway #9 in front of PP&G - \$116,000** ~ There was a lengthy discussion suggesting that we pay ½ of the \$116K, by Council Member Branham; and Council Member Lucas making the statement that L&C is a private enterprise & Chester County is not responsible. Council Member Oliphant asked if this would qualify for the 25% of the state portion to be used? This was taken as information, pending the next CCTC Meeting.
4. **Introduction of Lindsey Drive into the county road system** ~ After looking into the guidelines and discussion, L.B. Cannon stated that it does not meet the criteria. After Attorney Winters explained what an easement is, Council Member Branham motioned to present an easement to the landowner to sign in order to bring this driveway/property into the system, 2nd by Council Member Lucas. **The council voted, 5-0 to approve.**
5. **Introduction of Collins Street into the county road system** ~ Council Member Oliphant asked “**who paved this street?**” “**Does anyone know who owns this street?**” L.B. Cannon did not know the answers to these questions. Motioned by Council Member Lucas to put Collins Street on the next County Council Meeting Agenda, 2nd by Council Member Oliphant. **The council voted 5-0, to approve.**
6. Bids for flooding issues and repairs on the county road system \$91,320 – L.B. Cannon A) Blade Run Road & B) Hopps Road
7. Introduce the Infrastructure Consulting & Engineering (ICE) who will handle bid process of the non-reoccurring C-FUND
 - A. To finalize a secondary road list for bid process

IV. Adjourn ~ Motion made by Council Member Lucas, 2nd by Council Member Holcombe to adjourn the CCTC Meeting. The council voted unanimously 5-0, to adjourn.
