### MINUTES

Chairman Stuart stated he attended the Catawba Regional Transportation Advisory Committee and was informed the intersection would be expanded to include a turning lane onto Hwy 72 and McCandless Road because of heavy traffic. At that meeting, SCDOT stated if they move to far onto property owners land it would take acreage from their property and they could not be taxed as agriculture land use. SCDOT has agreed to bring it back but not cross into the land owners properties. He stated they were also going to improve the intersection of Saluda and J A Cochran Bypass as well.
