#### **MINUTES**

**Present:** Chairman Shane Stuart, Vice Chairman Joe Branham, Council Member Brad Jordan, Council Member Archie Lucas, Council Member Alex Oliphant, Council Member Pete Wilson, Council Member Mary Guy, Clerk to Council Karen Lee and County Attorney Joanie Winters.

- 1. Call to Order-Chairman Stuart called the meeting to order.
- 2. Approval of September 4<sup>th</sup>, 2018 CCTC Minutes.

  Council Member Lucas motioned to approve, second by Council Member Guy. Vote 6-0 to approve.

### 3. Old Business

## a. Approve Bid on Hanging Signs on the Bypass.

Chairman Stuart stated this was being brought back to CCTC, the original person would not install for the price that was approved. The signs are complete along with the hardware, the price has changed so therefore it's back on the agenda. Council Member Oliphant motioned to discuss, second by Vice Chairman Branham. Matt Hines, engineer with the Dennis Corporation stated this was solicited out to all of the sixteen bidders who were allowed by SCDOT to work on traffic signals. Out of the fifteen bidders to respond only two bids were recommended approval, WM Roebuck for \$13,423.20 cents and J. Moore for \$49,900.00 dollars. He recommended approval of WM Roebuck for the low bid of \$13,423.20.

The price difference was attributed to the fact from the advice from DOT, the original contractor was already in the area performing work and had minimal mobilization of traffic control prices and would be able to do the work. With the delay and delivery of the hardware for the signs the original contractor had moved on. Mr. Hines stated if the original contractor had been able to bid for the second time it would have put him as the low bid for this project. Council Member Oliphant asked what the original bid was approved before. Chairman Stuart stated \$3750 for the installation but jumped to \$13,423.20 in February of this year. Chairman Stuart asked if this is approved tonight when would the signs be installed.

Mr. Hines stated he would notify the contractor tomorrow or Wednesday to get it scheduled. Council Member Wilson asked if Mr. Hines would explain for the benefit of the public what the signs are. Mr. Hines stated they're street name signs that would be installed around J A Cochran Bypass for better visibility. Council Member Oliphant motioned to approve the bid from WM Roebuck for \$13,423.20, second by Council Member Jordan. Vote was 6-0 to approve.
