Organizations who are requesting a property tax exemption must complete PT-401-O.

Real Property (Land, Buildings, and Mobile Homes) and Personal Property (Vehicle, Furniture, and Fixtures) Exemptions for Organizations

Claims for refund must be received within 2 years from the date taxes were paid.

Real Estate Taxation is a year in arrears, meaning to be exempt for the current year, you must be the owner of record and your effective date of disability must be on or before December 31 of the previous year.

Exemption Sections:

Required documentation is listed for each exemption.

A(2) - Schools, colleges, other institutions of learning, charitable institutions in the nature of hospitals

Provide copies of the following:

- Vehicle registration card, bill of sale, or title

If this is an application for a charter school and the property is leased, provide copies of the following:

- Fully executed lease agreement

A(3) - Churches, parsonages, burying grounds, and public libraries

Provide copies of the following:

A(4) - Charitable trusts and foundations

A(11) - Public Benefit corporations

Established by a county or municipality used exclusively for economic development purposes. Provide copies of the following:

- Ordinance that established the corporation

B(4) - Nonprofit corporation created for providing water supply or sewage disposal, or a combination of such services

- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws
- HUD documentation showing that property qualifies within the above stated statute

B(11)(b) - Nonprofit housing corporations

Devoted exclusively to providing below-cost supportive housing for elderly persons or households authorized by Section 202 of the Housing Act of 1959 as amended under Section 801 of the National Affordable Housing Act of 1990 and regulated in part by 24 CFR Part 889. Provide copies of the following:

- Recorded deed
- · Vehicle registration card, bill of sale, or title
- IRS exempt Determination Letter
- · Stamped South Carolina Articles of Incorporation and bylaws
- HUD documentation showing that property qualifies within the above stated statute

B(11)(c) - Nonprofit housing corporations

Devoted exclusively to providing below-cost housing for persons with disabilities authorized by Section 811 of the National Affordable Housing Act of 1990 and regulated in part by 24 CFR Part 890. Provide copies of the following:

- Recorded deed
- Vehicle registration card, bill of sale, or title
- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws
- HUD documentation showing that property qualifies within the above stated statute

B(11)(d) - Nonprofit housing corporations

Devoted exclusively to provide below-cost housing for persons with disabilities authorized by Section 515 of Title V of the Housing Act of 1949. Provide copies of the following:

- Recorded deed
- · Vehicle registration card, bill of sale, or title
- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws
- HUD documentation that property qualifies within the above stated statute

B(11)(e) - Nonprofit housing corporation or solely owned instrumentalities of these corporations

Devoted to providing housing to low or very low income residents. This corporation must satisfy the safe harbor provisions of Revenue Procedure 96-32 issued by IRS. Provide copies of the following:

- · Recorded deed
- · Vehicle registration card, bill of sale, or title
- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws
- Proof that corporation meets safe harbor provisions of IRS Revenue Procedure 96-32

B(12) - Fraternal society, corporation, or association

Provide copies of the following:

- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws

B(16)(a) - Religious, charitable, eleemosynary, educational, or literary society, corporation or other association Provide copies of the following:

- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws

B(16)(b) - Religious, charitable, eleemosynary, educational, or literary society, corporation or other association

When property is acquired for building or renovating residential structures on it for not-for-profit sale to economically disadvantaged persons. Exemption may not exceed fifty acres per county within the State. Provide copies of the following:

- · Recorded deed
- Vehicle registration card, bill of sale, or title
- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws

B(16)(c) - Religious, charitable, eleemosynary, educational, or literary society, corporation or other association Donated or purchased property held for future use. Provide copies of the following:

- Recorded deed
- · Vehicle registration card, bill of sale, or title
- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws

B(18) - Real Property leased on a nonprofit basis to a state agency, county, municipality or other political subdivision

Exemption shall not apply to property used for office space or warehousing. Provide copies of the following:

- Recorded deed
- · Lease agreement, if leased

B(19) - Volunteer Fire Departments and Rescue Squads

Provide copies of the following:

- · Recorded deed
- · Vehicle registration card, bill of sale, or title
- Lease agreement, if leased

B(20) - Nonprofit museums

Provide copies of the following:

- · Vehicle registration card, bill of sale, or title
- IRS exempt Determination Letter

B(21) - South Carolina Public Service Authority for the generation or transmission of electric power

B(22) - Community owned recreation facilities

Open to general public and operated on a nonprofit basis. Provide copies of the following:

- Recorded deed

- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws

B(24) - Nonprofit or eleemosynary community theater companies, symphony orchestras, county and community arts councils and commissions

Used exclusively for the promotion of the arts. Provide copies of the following:

- Recorded deed
- · Vehicle registration card, bill of sale, or title
- IRS exempt Determination Letter
- · Stamped South Carolina Articles of Incorporation and bylaws

B(25) - Personal property loaned or leased on a nonprofit basis

To a state agency, county, municipality, or other political subdivision. Provide copies of the following:

- Title and/or bill of sale to personal property
- · Lease agreement, if leased

B(28) - Carnival equipment

Owned, leased, or used by a foreign corporation or other nonresident of this State. Provide copies of the following:

- Title and/or bill of sale to personal property
- · Lease agreement, if leased

B(31) - Churches

Property which extends beyond the buildings and premises actually occupied by the churches. Provide copies of the following:

- Recorded deed
- IRS exempt Determination Letter
- Stamped South Carolina Articles of Incorporation and bylaws

B(36) - Land subject to perpetual easement

Donated to this State under South Carolina Scenic Rivers Act. Provide copies of the following:

- · Easement agreement
- · Recorded deed showing easement

B(42) - Property held by charitable trusts and foundations

Held for historic preservation of forts and battlegrounds which extends beyond the buildings and premises actually occupied. Provide copies of the following:

- · Recorded deed
- · Vehicle registration card, bill of sale, or title
- IRS exempt Determination Letter
- Documents creating the trust or foundation
