**Mr. Tommy Darby, Treasurer and Finance Director** gave an overview of the 2013-2014 budget with the total being \$26,272,206.

**Vice Chairman Branham** asked was the payment made on the jail bond a once a year payment and **Tommy Darby – Treasurer/Finance Director** replied it was and usually in November and we were about a year to a year and a half ahead of schedule. **Council Member Holcombe** asked if it was for seven years and **Chairman Roddey** replied it was. **Council Member Lucas** asked how do you think the people would react to a one cent road tax like York County has and **Council Member Guy** said she thought it would pass. **Chairman Roddey** said if Council could come up with one thing we could probably pass it. **Vice Chairman Branham** then said it would have to be done in a general election.

**Vice Chairman Branham made a Motion to approve 3<sup>rd</sup> and final reading Of the 2013-2014 Chester County Budget Ordinance, 2<sup>nd</sup> by Council**

**Member Holcombe.** Discussion: **Vice Chairman Branham** asked was there any possibility of getting another employee for Economic Development and **Chairman Roddey** said it was very unlikely. **Council Member Jordan** then suggested that Ms. Parker come before Council at a later date and give us some information on adding another person. **Council Member Lucas** asked if the grant matching funds were obligated and **Chairman Roddey** replied no. There was no further discussion so **Chairman Roddey** called for the vote.

**Council then voted and the vote was unanimous.**
