1. 2<sup>nd</sup> Reading of Chester County Budget Ordinance

**Vice Chairman Branham made a Motion to approve 2<sup>nd</sup> Reading of the 2013-2014 Chester County Budget Ordinance, 2<sup>nd</sup> by Council Member Jordan.**

**Council Member Guy** asked would property taxes go up and **Tommy Darby/Interim Finance Director/Treasure** said we would not know until the millage was set in September. **Council Member Jordan** asked if there would be an increase on Debt Service and **Mr. Darby** replied we wouldn't know that either until September. **Vice Chairman Branham** asked how was Local Government Fund figured and **Chairman Roddey** said at the same rate as last year. **Chairman Roddey** also said there was a 3% increase for employees but would not take effect until January and the insurance and FICA went up. **Council Member Lucas** asked how much longer did we have on the Jail Bond and **Mr. Darby** replied until 2017 but we were a year and a half ahead of schedule. **Council Member Jordan** inquired about budget request and Capital items that did not get funded. **Mr. Darby** said we just basically did not have funding available for all of the requests. **Vice Chairman Branham** then suggested that we think about adding three to four employees to the Economic Development budget in the future. **Council then voted on the 2013-2014 Fiscal Budget and the vote was unanimous.**

2. A Resolution to Permit the Chester Development Foundation to Bestow Naming and Recognition Rights to all locations with the Gateway.  
**Council Member Guy made a Motion to approve A Resolution to Permit the Chester Development Foundation to Bestow Naming and Recognition Rights to all locations with the Gateway, 2<sup>nd</sup> by Vice Chairman Branham, Council vote was unanimous.**
