- 1. Award Bid for Chester County Parking Lot

**LB Cannon/Dennis Corp.** stated bids had gone out for this project and only one bid came back. Boggs Paving came in at \$377,202.00. The estimated bid would have been between \$376,000.00 and \$387,000.00. **Mr. Cannon** stated he had contacted other contractors and they told him at the present time they had too much DOT work going on, thus the one bidder. **CCTC Member Lucas** said he was very disappointed that CCTC was going ahead with this project when Main Street in Great Falls was to have been started in the fall. **Mr. Cannon** and **CCTC Chairman Roddey** both replied to **CCTC Member Lucas** that the county had given DOT the funds that the Great Falls Street-scape Committee was holding up the project and DOT would start once that committee had made a final decision on what they actually wanted to do.

**CCTC Chairman Roddey then asked for a vote, CCTC Member Jordan made a Motion to award the bid to Boggs Paving in the amount of \$377,202.00, 2<sup>nd</sup> by CCTC Member Holcombe, CCTC vote was 3 to 1 to approve with CCTC Member Lucas opposing.**
