II. New Business

1. Approval of CCTC Meeting Minutes of September 8, 2009

Vice Chairman Lucas made a Motion to approve the CCTC Meeting Minutes of September 8, 2009, 2nd by Council Member Holcombe, CCTC vote was unanimous.

III. Old Business

1. DOT Contract for 2010

Mr. L.B. Cannon first introduced two ladies from SCDOT in Columbia, Ms. Tina Feaster and Ms. Clairce Gibbons. **Chairman Roddey** welcomed them to the CCTC Meeting. Mr. Cannon then said that Mr. Bradley (SCDOT Engineer) had been out of the office

1 for the last two weeks and he had been unable to get any dollar amounts on the
2 roads the CCTC had decided on. Mr. Cannon added that Mr. Stan Bland had written
3 a letter saying he would add Peden Oaks under a DOT maintenance contract.

4 2. Road Improvement Program 2009

5 Mr. Cannon said that the bids had been opened in September and that the contractor
6 started laying pipe and reshaping roads on the 22nd. The reclamation crew moved in
7 October 1 but the weather has prevented them from doing anything since then.

8 **Vice Chairman Lucas** asked if they could work past October and Mr. Cannon replied
9 they could, weather permitting.

10 3. Ballymenia Road

11 Mr. Cannon then said that on Ballymenia Road, SCDOT had given him a "punch list"
12 and that Dennis Corporation had just about completed their part. **Council Member**
13 **Oliphant** asked if the sidewalks had to be widened and Mr. Cannon said the sidewalks
14 were given the OK.

15 At this time Ms. Feaster asked is she could speak briefly to the Committee and

16 **Chairman Roddey** replied she could. She thanked the CCTC for allowing them to
17 attend the meeting and Mr. Cannon and Mr. Antley for what they were doing.

18 Ms. Feaster did mention a report that was due and Mr. Cannon said he would look
19 into it. Ms. Feaster then invited Council to their Annual Meeting on December 10th and
20 **Chairman Roddey** said they couldn't attend but would ask Mr. Cannon and Mr. Antley
21 to attend.

23 **Council Member Holcombe made a Motion to adjourn, 2nd Council Member**
24 **Branham, CCTC vote was unanimous.** Time was approximately 5:55 pm
